National Revaluation Programme – Dún Laoghaire-Rathdown County Council

Dear Ratepayer,

You may recall that the Commissioner of Valuation wrote to all occupiers of rateable property in the rating authority area of Dún Laoghaire-Rathdown County Council on October 15th last year. He advised that he had signed a Valuation Order for the Dún Laoghaire Rathdown County Council area and that the revaluation of all commercial and industrial properties for rates purposes in that local authority area had commenced and would be concluded in September 2020.

Due to the impact of COVID-19, the Commissioner of Valuation, with the consent of the Minister for Housing Planning and Local Government, has deferred the revaluation of rateable properties in the Dún Laoghaire-Rathdown County Council area from 2020 until 2021. Accordingly, I wish to advise that the revaluation of the rating authority area of Dún Laoghaire-Rathdown will now be finalised in September 2021 and become effective for rates purposes from 2022 onwards.
