I, John O’Sullivan, Commissioner of Valuation, in exercise of the powers conferred on me by section 21(4) of the Valuation Act 2001 (No. 13 of 2001) (as amended by section 8 of the Valuation (Amendment) Act 2015 (No. 10 of 2015)), with the consent of the Minister for Housing, Local Government and Heritage (as amended by the Valuation Office and Valuation Tribunal (Transfer of Departmental Administration and Ministerial Functions) Order 2017 (S.I. No. 575/2017) and adapted by the Housing, Planning and Local Government (Alteration of Name of Department and Title of Minister) Order 2020 (S.I. No. 408/2020)), hereby order as follows:

1. The Valuation Acts 2001 to 2015 (Dún Laoghaire - Rathdown County Council) Valuation Order 2019, as amended by the Valuation Acts 2001 to 2020 (Dún Laoghaire - Rathdown County Council) Valuation Order 2020, is amended -
 - a. by substituting for “15th September 2021” the publication date “15 September 2022” and
 - b. by substituting for “29th October 2021” the effective date “28 October 2022”,
2. This order may be cited as the *Valuation Acts 2001 to 2020 (Dún Laoghaire - Rathdown County Council) (Amendment) Order 2021*.
